The Marion County Board of Commissioners met in a regular called session on September 24, 2018. Chairman Gene Hargis called the meeting to order. Invocation was given by Chairman Hargis. Roll call was taken by Dwight Minter, County Clerk. Fifteen commissioners were present.

- 1) A motion was made by Commissioner Adkins and seconded by Commissioner Grayson to approve the minutes from the August 27, 2018 meeting. 15 voted aye.
- 2) A motion was made by Commissioner M. Blansett and seconded by Commissioner Grayson to accept the nomination of Gene Hargis as Temporary Chairman. 15 voted aye.
- 3) A motion was made by Commissioner Hargis and seconded by Commissioner M. Blansett to accept the nomination of David Abbott for Chairman. 15 voted aye.
- 4) Chairman Abbott asked for nominations for Vice Chairman. Commissioner Franklin nominated Joey Blevins and Commissioner Skiles nominated Donald Blansett. A motion was made by Chairman Abbott to cease nominations. 15 voted aye to cease. Roll Call Vote for Vice Chairman, resulting in Donald Blansett being elected as Vice Chairman. 6 voted for Blevins, 9 voted for Blansett (which is attached).
- 5) A motion was made by Commissioner M. Blansett seconded by Commissioner Grayson to accept the Building Use Committee's recommendation to approve location of the Child Advocacy & American Job Center to the Commission Building. 14 voted aye, 1 nay (Reeves).
- 6) A motion was made by Commissioner D. Blansett and seconded by Commissioner Kirk to table the Petition to close Crossroads R (Cross Creek Road and Wynne Wash Road) to the next meeting. 12 voted aye, 3 voted nay (Hargis, Adkins and M. Blansett).
- 7) A motion was made by Commissioner Adkins and seconded by Commissioner D. Blansett to approve the Marion County Board of Education Multi-Lease Agreement with Beeler for 60 months at \$236.17 per month. 15 voted aye (which is attached).
- 8) A motion was made by Commissioner Thompson and seconded by Commissioner Grayson to approve the Marion County Board of Education monthly financial report for August 2018. 15 voted aye (which is attached).

9) A motion was made by Commissioner Reeves and seconded by Commissioner Kirk to approve the following Notaries: Lynn Guffey, Patricia A. Hookey, Hannah E. Kerr, Heather N. Pickett, Jamie K. Rector and Laura L. Tuders. 15 voted aye.

10) A motion was made by Commissioner Hargis and seconded by Commissioner Grayson to Adjourn. 15 voted aye.
